



Kayak Angler Shoot-Out Official Rules, Waiver & Entry Form

Kayak Angler Shoot-Out - 1 Day Kayak Fishing Tournament

Saturday, October 15, 2011 - Amateur Tournament - Westside of Big Island

In-Shore and Off-Shore - 1st, 2nd & 3rd place per division - \$40. Per division - \$65 for both

Contest Rules:

This is a one day event beginning at 6:00 a.m.

Final weigh-in is at 3:00pm @ Sheraton Keauhou Bay Resort on the Crystal Blue Terrace Lawn.

In-Shore: Ulua, Kahala, O'milu, Kagami, Kaku, Uku, Kumu Aha and all reef fish such as Roi, Palani or Kala.

Off-Shore: Ahi, Mahi, Ono, Aku, Kawakawa, Spearfish and any billfish.

The species not listed will be classified by contest officials. All fish must be "in season".

The Angler with the heaviest fish in each division wins. Prizes are 1st, 2nd & 3rd in each division.

Honor system observed, Violators of rules will be disqualified from this & future contests.

All fish must be caught while fishing with rod and reel from a Kayak. NO BAITING

This is a Kayak Paddling Fishing event, no assistance from motorized/wind powered vessels.

The following sea life not allowed for entry: Eels, Turtles, Rays, Sharks and Marine Mammals.

Life Vest and safety whistle is mandatory for all Anglers. No frozen, previously frozen or rotten fish will be allowed.

Official weigh-in time of 3pm will be observed, no late entries. Officials award prizes after weigh in process is complete.

Unsportsmanlike behavior/cheating will not be tolerated and is grounds for DQ from this & future Kayak Fishing Hawaii Tournaments.

All Entries must be received by no later than Midnight October 14th - NO EXEPTIONS.

Kayak Fishing Hawaii Release & Indemnity

I will abide by all the Rules and Regulations of the "Kayak Angler Shoot-Out" kayak fishing contest. If officials of the kayak fishing contest determine that I have violated any Rules or Regulations, I will forfeit all monetary and merchandise awards. I understand that participating in the "Kayak Angler Shoot-Out" Contest can be dangerous and could result in loss of property and personal injury, including death. On behalf of my heirs, my personal representatives, and myself, I hereby release Kayak Fishing Hawaii from any and all liability and responsibility, which they or any representative of, may incur as result of any and all property damage and injuries – including death which I may suffer or incur in connection with, or as a result of my participation in the "Kayak Angler Shoot-Out" contest. Marine/Ocean Waters Event - Hold-Harmless Agreement Indemnifying the State of Hawaii against Any Liability

1. Liability Release: In signing this release I hereby release the State of Hawaii, Department of Land and Natural Resources, Division of Boating and Ocean Recreation (herein referred to as the State) it's officers, agents, employees, and all departments from any and all damages, claims, demands, costs, or expenses relating to injury or death of any persons or damage to any property which I may sustain or which I may cause by reason of participating in, or in connections with the "Kayak Angler Shoot-Out" kayak fishing contest.
2. Covenant not to sue and waiver of subrogation: I further agree that I will never sue the State for damages of account of any injury or damage I suffer or cause whether known now or which may develop in the connection with this event. In the event the State is sued because of my actions, I expressly agree to indemnify and hold the State harmless of any liability whatsoever, including court cost and attorney's fees, arising with respect to such actions. I understand that in waiving my rights to sue the State, I also am waiving the rights of recovery from the State of my insurance carrier for any claims they may pay on my behalf. I further understand that by signing this agreement, I waive any rights my heirs or relatives have or may have to sue the State for liability.
